

Sunscreen Information and Permission Form

Dear Families,

Please read carefully! We ask that families put on the first application of sunscreen in the morning before arriving at Blossom. With your permission, Blossom will apply the following sunscreen to your children once a day after naptime or as needed after waterplay.

Sweet Pea, Buttercup, Daisy, Lilac, Honeysuckle, and Snapdragon Classes: Parents to provide sunscreen to be applied at Blossom.

Willow and Sunflower House Groups: Blossom to provide Rocky Mountain SPF 50 Kids Broad Spectrum Sunscreen Spray

Rocky Mountain Sunscreen Information:

- Reef Friendly, Hawaii compliant (free of oxybenzone and octinoxate), Cruelty free
- Broad-Spectrum UVA/UVB protection. Gluten free. Free of PABA, fragrances, parabens. Hypoallergenic. Safe for all skin types including sensitive skin.
- Non-greasy lightweight and breathable formula. Great for active sports or everyday wear; will not leave your skin white and pasty. Feel the difference!
- Durable and water resistant for 80 minutes. Apply 15 minutes before sun exposure and reapply every 2 hours, or after toweling off. Approved for use by adults and children 6 months and older. This sunblock helps to decrease the risk of developing skin cancer, skin aging, and sunburns when used as directed.

If your child is in Sweet Pea, Buttercup, Daisy, Lilac, Snapdragon, Honeysuckle classrooms **or** you are choosing to opt-out of using Rocky Mountain Sunscreen and supplying your own brand, please be sure to write your child's name on the bottle and cover the name with clear tape (the oils in the lotion wipe off even permanent marker). In the absence of an alternative, we will automatically apply Rocky Mountain Sunscreen on children in our care, unless you indicate otherwise. If you wish to waive the use of sunscreen on your child entirely, you may check the box on the Permission Slip.

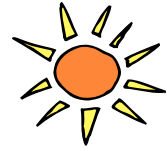
With warmer weather on the way, please remember the following:

- **Always apply sunscreen to your child before arriving at Blossom.** We assume all children have sunscreen applied and will only re-apply as needed throughout the day.
- Be sure at least one of your child's extra outfits is a warm weather option.
- **No open-toes sandals,** even with socks. Children may wear aqua socks, tennis shoes, or closed-toed sandals.
- We highly recommend children have a sun hat and/or other sun clothing available in their cubby (please label with your child's name).
